## 2019 Contract A-19 Road Construction

*Hazen Road: Town Hall Road – Verlin Road,  
Marco Court, Collier Court, Casual Court, Leisure Court,  
And Jubilee Drive*

**Project information:** Multi-Phase Construction involving sanitary sewer repairs and lateral lining/replacement, storm sewer repairs, new sidewalk, street tree installation, and street pavement reconditioning. Phase 1 is Hazen Road from Bluestone Place to Verlin Road, including Marco Court and Collier Court. Phase 2 is Hazen Road from Allouez Avenue to Bluestone Place. Phase 3 is Hazen Road from Town Hall Road to Allouez Avenue, including Jubilee Drive, Casual Court, and Leisure Court.

**Timeline:** Construction April 2019 - August 2019

**Road Closures, Vehicles & Traffic:** While under construction, the road will be closed to through traffic. Travel through the area will be possible, but delays are likely due to construction equipment using the area. Be attentive of construction workers directing traffic through the construction zone.

**Resident Access:** Local resident access to and from your home will be maintained as much as possible during construction. If your driveway needs to be closed while construction is taking place, you will be notified by knocking on the door and leaving a door hanger in advance of the closure. Please contact the project inspector, **Cedar Corporation** if you require special access needs.

**Communication:** It is the intent of the Village to minimize the amount of disruption and inconvenience to the community during any construction process. If during normal work hours you feel something went unnoticed, or needs attention, please contact **Cedar Corporation**. As project inspector, Cedar Corporation is most familiar with the daily operations of construction and can resolve many issues quickly.

If something happens after normal work hours that you feel requires immediate attention, please contact **David Betts**, and arrangements will be made to resolve the issue.

As always, in an emergency, please call 911.

Please leave your door hanger on the door and keep an eye it for construction updates regarding paving, garbage pick-up, and traffic changes. Additional information is available on the Village website.

### Two Week Outlook:

Week of 4/29/19: Continue pavement removal, curb and gutter removal, roadway and sidewalk excavation, and base course in Phase 1 and Phase 2. Construct curb and gutter in Phase 1 and cul de sacs north of Allouez Avenue.

Week of 5/6/19: Continue pavement removal, curb and gutter removal, roadway and sidewalk excavation, and base course in Phase 1 and Phase 2.
