SIGNATURES & TERMS OF USE

The applicant hereby agrees to the terms of use for disposing approved materials at the Village of Bellevue Compost site. Unlawful use of the site, including giving false information such as business address, shall immediately revoke the privileges of this permit and use of the site. Fines and citations will be issued for violation of the permit conditions in addition to loss of permit privileges and application fee.

Terms of Use

- The contractor and the above listed vehicles are allowed to dispose of yard waste (leaves, grass, garden waste), and brush under 1-inches in diameter in the designated areas.
- Larger branches and trees may be allowed for disposal only if approved by the Director of Public Works or designee prior to disposal.
- All bags, boxes and paper shall be disposed of by the contractor.
- No metal, construction materials, or debris with rocks or stones is allowed for disposal. The cost of removing contaminated materials shall be billed to the contractor along with fines and citations.
- This permit is valid in the year of issuance, expiring on December 31st of the year of issue. Permit fees will not be prorated for a partial year permit.

Fines

- Contractor use of the facility without a valid vehicle permit will be fined \$500 plus the cost of a contractor permit
- Dumping of materials not allowed on site will be fined \$1,000 plus the cost of removal of illegally disposed material

Local Contractor

- Local Contractors are defined as follows:
 1. An established business with a mailing address located within an appropriate Village zoning district. Storage facilities will not be considered legitimate business addresses.

 2. An established business with a mailing address located in a Village residential R-1, R-2, or RR zoning district and holds a Home Occupation Permit approved and on file with the Village.
